## Manufacturing Procedure (pilot - Trimix - 7 kg)

Weigh phase B ingredients and incorporate it into the main tank of the Trimix. Homogenize phase B ingredients in order to ensure the good dipersion of Sepimat HB V. Add phase A onto phase B and homogenize well. Once the formula is smooth, add the remaining ingredients while homogenizing. Adjust the pH to 5.5 with the Sodium Hydroxide.

They are easy to use as they are dispersible either in the oil phase or in the aqueous phase, this property allows formulators to make very powdery formuations containing low level of oiy materials. In O/W, W/O or W/Silicone emulsions, only 0.1% of SEPIMAT HB V is enough to prevent formulations from being greasy and to get a powdery feel.
