Translucent Liquid with Visible Oil Droplets / Packaging: Dropper

pH: 6.3 / **VISCOSITIES:** **1M** at RT: 1,150 mPa.s Brookfield LV4-6 /
Recovery at RT (after 1M at 45°C): 1,000 mPa.s Brookfield LV4-6.
STABILITY: 1M at RT, 45°C, -18°C & freeze/thaw cycles -5°C/+40°C.

FORMULATION ADVICES: Laboratory scale - 300 g - IKA stirrer

Weigh phase A, leave it for hydration 10 minutes. Stir with defloculator for 10 minutes at 800 rpm. Add phase B under anchor stirring 150rpm 10 min. Pre-mix phase C, add phase C into the main beaker under anchor stirring 150rpm 10 minutes.
