FORMULATION ADVICES: Laboratory scale - 2 kg

Weight the water, the Hydrolisat de Rose, AQUAXYL™ and the glycerin, and add one by one into a beaker while shaking with a spatula. Then, mix under agitation during 5 minutes. In another beaker, weight other ingredients (except acid). Then, add the second beaker into the first one under magnetic agitation. While mixing, adjust the pH up to 3.5–4 with the Lactic Acid.

This hydrating intimate foam at pH 4 is particularly recommended for sensitive skins. Its texture limits contact irritations: no need to rub to have a foaming solution.
