FORMULATION ADVICES: Pilot - 6 kg - Trimix - Rotor Stator

Heat phase B up to 85°C, then add phase C, let 5 min under heating. Meanwhile, heat phase A up to 85°C, add the mixture (B+C) into phase A, emulsify during 5 min. When the blend is homogeneous cool down to 65°C. Then, add phase D and cool down to 40°C under vacuum. Add phase E still under vacuum. Finally, cool down and check the pH.
